#### How long we keep information

We only keep your personal data for as long as necessary to provide the Jury game service. All data (such as player IDs, usernames, game history, ad consent choices, and support enquiries) is retained for a maximum of 12 months from your last activity, after which it is securely deleted or anonymised. Temporary logs (such as crash reports and device information) are kept for no longer than 90 days.

We do not keep any sensitive personal data, and any aggregate statistics we use for improving the service are stored only in an anonymised form. You may request deletion of your data at any time by contacting us.
